- **Cumulative two-year (7<sup>th</sup>/8<sup>th</sup>) grade average of “80” in all classes (Students enrolled in advanced courses must maintain a 75 percent average or better each nine weeks as per district policy)**
- **90% attendance or better in all classes**
- **Good citizenship (Satisfactory or better)**
- **Must reside within EPISD boundaries (The district will provide transportation for students attending a magnet school outside of their attendance zone.)**
