Franklin High School values the partnership with parents in their children's education. There are many ways parents can make significant contributions to student success both at home and at the school. Student achievement is the result of effective home-school-community partnerships.

Franklin High School will take the following actions to involve parents in the process of school review and improvement.

- **Conduct Annual Title I meetings at a convenient time. Parents are encouraged to share input/suggestions.**
- **Parents will be offered flexible number of meetings in the mornings and evenings.**
- **Parents are invited to be part of school parental involvement activities.**
